# Blue Colorant/ Closed Lagoon Pilot Project

The blue colorant pilot began in Lagoons 3 to 5 on May 17. The initial application resulted in a color change so subtle that many residents did not visualize it at all; with less than desired darkening of the water, the algae growth impact would also be minimal. On June 2, we began filling Lagoons 1 and 2, with back-fill from Lagoons 3-5 through the Willow St. weir (at Alameda Hospital), and pumping from the Bay at Lagoon 1. As all Lagoons neared summer levels, the blue colorant was applied in all five lagoons on June 14. Based on the under-coloration in May, a higher application rate was utilized on June 14. This time, the coloration change was very obvious—exceeding the goal of our maintenance team (and that of many residents—although some were also very pleased with the intensity). The colorant, an organic product, naturally degrades. We have closely followed the coloration effect. and maintenance contractor is adjusting reapplication rates as appropriately as possible, striving for an optimal balance.

The colorant is expected to decrease algae growth and improve water clarity. With the filling of Lagoons 1 and 2, in the week prior to colorant application, there was a marked increase in cloudiness. which coincided with a spike in bacterial counts. Source of the bacteria is unclear; however, there was back-filling through Lagoon 3, where a recent sewage source was identified and sealed, and where sediment was recently cleared adjacent to the mini-park. Bacterial counts have spiked occasionally in the past at Spring draw-down; at our previous monitoring frequency of once per month, the counts typically normalized by the next sampling. With the closed lagoon/colorant trial, we are monitoring more frequently. Associated with this increased frequency, we have had serial elevated levels, which in the end, are currently back to normal, one month after completion of filling. We are not aware of any ongoing source of contamination, and we are anticipating that the bacterial counts will stay low; additionally, we are hopeful that the

colorant will now help keep future algae blooms under improved control.

The new AWLHOA website has been used by many members to comment on this Summer management pilot. We have received several positive comments. We have also received some concerns-common themes include effects on waterfowl, fish, and bacteria. The blue colorant is an organic compound, safe waterfowl and fish. With darker water, though, it is more difficult for residents, and birds, to see the fish. Hence, bird numbers on the lagoons may be lower. Nonetheless, our maintenance team continues to observe widespread healthy fish. The recent bacterial spike pre-dated colorant application—and the spike has cleared for now, with the colorant still in place. maintenance team is also serially following dissolved oxygen levels and water temperature — both are within acceptable limits, with, as some of you may have noticed, water

# **Dredging Project**

The dredging project is in the final stages of the permitting phase. The bulk of the necessary information regarding the location, the quantity, and the chemical quality of the material to be dredged has been collected. The final piece of the puzzle is to determine the disposal site for the dredged material.

The consultant (CLE) has already estimated the costs for disposal at a commercial landfill such as the Altamont disposal site, but the costs could be cut nearly in half, if the dredged material could be used at Alameda Point. As part of it's cleanup activities at the former Alameda Naval Air Station, the Navy needs fill and cover material for the final closure of some of it's old landfills. CLE is currently in the process determining whether or not the dredged material from the lagoons will meet the Navy's acceptance

criteria.

Once the disposal site has been selected the completed permit application can be submitted to the Dredge Material Management Office, the final permit can be issued, and the City can seeks bids for the actual dredging of the lagoons.

An Election Inspector has been appointed and been provided within the legal requirements under which the election must be conducted. The Election Inspector has the option to appoint up to 2 assistants if desired.


